2. The article must contain the following details:
\Box index of the universal Decimal classification of literature (UDC) (placed in the upper left corner);
Russian Russian and English languages), abbreviation in the title is not allowed!!!
\square Surnames, first names, patronymics of all authors in full (in Russian and English) with indication of academic degree, title and position;
\Box full name of the organization (full and abbreviated version) with indication of the city (in Russian and English);
abstract (consists of 20-70 words, placed under the name of the organization, written in italics); the abstract is given in Russian and English;
☐ Citation is not allowed in the abstract;
3-4 keywords are highlighted in a separate line (in Russian and English);
\Box the text of the article (7-12 pages (for one author), margin sizes: left and right -2.25 cm, top and bottom -2.5 cm, paragraph -1.25 cm, line spacing -1 , header and footer -1.25 cm);
\Box The page format is B5 (17.6 x 25 cm);
endnotes and arrangement of pages in landscape format are not allowed in the text of the manuscript;
references (bibliographic references are given at the end of the text in alphabetical order by automatic numbering of the list, the text in square brackets indicates the serial number according to the list of references and the page, for example, [5, C. 121]). In–text, subscript and out-of-text bibliographic references (references) should be drawn up in accordance with GOST R 7.05-2008 "Bibliographic reference. General requirements and rules of compilation", for example:

When typing, the Times New Roman font is used (size 10 pt, line spacing -1), there is or space between words in the entire text, straight quotes " ", a short dash (except for common word such as somehow, somewhere, etc.). The space between the number and the percentage sign is n It is being staged.
5. Illustrations are made in the form of graphic files as a single object. All illustrations a accompanied by captions (not repeating phrases-links to drawings in the text), including the number, title of the illustration and, if necessary, symbols.

for example, (2). Values indicated in Latin letters, as well as simple formulas are typed in italics, more complex formulas are performed using the formula editor of the MS Word program.

The structure of the article

The title of the VAC article

The title is the most important element of the article. The way the title of the article is formulated largely determines whether the reader's attention will stop at it when he gets acquainted with the contents of the journal. The title should clearly, clearly and unambiguously formulate the problem, and at the same time be quite brief: not more than 5-6 words.

Abstract to the scientific article of the Higher Attestation Commission

The author's task in 4-6 sentences is to express the essence of the problem under study, its relevance and methods of solution. An abstract is not the content of an article, but rather its characteristic. It gives an idea of the significance of the work and the novelty of the results obtained.

Keywords

The keywords that make up the semantic core of the article are a list of basic concepts and categories that serve to describe the problem under study. These words are used by search engines to find an article on the Internet. Currently, in order to publish a scientific article, it is necessary to pay due attention to the formation of the semantic core.

Introduction

This section describes the general topic of the study, the goals and objectives of the planned work, the theoretical and practical significance of the work, provides the most well-known and authoritative publications on the topic under study, identifies unresolved problems. This section often contains information about the structure of the article.

The main text

The main part takes up two thirds of the entire article and should fully reflect the process of research, obtaining results and proving their novelty. To do this, you must first specify the sequence of research stages, and then give a justification for the methods used.

We must constantly remember that the purpose of the article is one and the most important problem and you should not be distracted by the presentation and discussion of secondary, even interesting, problems. This may be the topic of other articles, but not this one.

When the goals, objectives and methods of research are defined, you can proceed to the presentation of the theoretical and empirical parts. After describing the analytical work carried out, it is worth proceeding to the presentation of the results obtained, which it is desirable to visually confirm with illustrations, graphs, tables, drawings, diagrams (more about the requirements of the Higher Attestation Commission for illustrations). This will give objectivity to the conducted research and emphasize the novelty of the results obtained. It is not advisable to use drawings and photographs from the Internet, they must be original.

When writing an article, special attention should be paid to the scientific style of presentation adopted in the scientific community. Slang, jargon, and the use of foreign words, the translation of which into Russian is ambiguous, should be avoided. The tone of the article should be correct and respectful towards all opponents. Any publication in the journals of the Higher Attestation Commission can serve as an example.

Conclusion

The conclusion is a small section in terms of volume, which contains the main ideas of the main text of the article in a concise form. This part of the section should be carefully edited so as not to repeat the wording given in the previous sections. It is advisable to compare the results obtained with those that were planned to be obtained, as well as to show their novelty and practical significance. At the end, conclusions and recommendations are presented, and the main directions for further research in this area are determined.

Bibliographic list

The list of used literature occupies an important place when working with an article. Many reviewers begin their acquaintance with the article from the bibliography. The more reputable the sources, the higher the degree of confidence in the article. For a scientific publication, it is necessary to specify at least 5 sources used in the article.

References to them are drawn up in the text in the form of square brackets indicating the number of the source in the bibliographic list and the page. The sources in the list of references are arranged alphabetically by the author's last name. Foreign authors are indicated at the end of this list.

The structure of a scientific article ultimately obeys the logic of the presentation of the material and the requirements of the journal in which this publication is planned to be published.
